L/C up to AED 100,000 or equivalent in other currency	0.15% per month – minimum charges 0.4% (not less than AED 1,050)
L/C over AED 100,000 or equivalent in other currency	0.15% per month on AED 100,000 + 0.075% per month on balance amount more than AED 100,000 Minimum 3 months charges will be charged. (not less than AED 1,050)
Back to Back L/C or Transferrable L/C	0.15% per month on AED 100,000 + 0.075% per month on balance amount more than AED 100,000 Minimum 3 months charges will be charged. (not less than AED 1,050)
Revolving L/C	0.15% per month – min. charges 0.075% (not less than AED 1,050) plus 0.15% flat on each negotiation
Extension and increase in value	AED 525 for normal amendments plus swift/courier cost. For extension and any value increased rates to be applied as stated above.
Acceptance Commission	0.15% per month flat (not less than AED 1,050) from the date of expiry of the L/C up to the maturity of acceptance or the date of payment, whichever is later L/C issuance commission is charged upfront every three months.
